**PAYMENT TERMS:**

- Monthly statements are generated the last day of the month with payment due on the 15<sup>th</sup> day of the following month (for example, statements issued March 31 are due April 15<sup>th</sup>)
- Members have the option to set up automatic bill pay using the credit card on file. Notify Patricia Johnson if you wish to do so.
- Any amount not paid by the 15<sup>th</sup> day of the month is considered “past due”
- If an account is not paid in full by the last day of the month the credit card on file is charged the past due amount. If a valid credit card is not on file, a 5% interest charge is charged on all balances over 30 days.

## MEMBERSHIP AGREEMENT

If accepted as a member of Belle Meade Country Club, I agree to conform to all rules and regulations and to pay all fees and assessments as set by the Board of Directors and the corporation by-laws. I further agree to pay my dues/fees in accordance with the options approved by the Board of Directors and to pay all charges made by me, my family, and guests promptly when due. I understand that if my account is not current within 60 days from the billing date, my Club privileges will be automatically suspended. Past due bills will accrue a late fee each month in an amount equal to a minimum late fee established by the Club from time to time and/or interest at a rate of 5% from the date of the statement until paid in full. I, the undersigned further agrees to pay all reasonable attorneys' fees, court costs and other expenses incurred in connection with the collection of my delinquent account.



# BELLE MEADE COUNTRY CLUB CLASSIFICATIONS OF CLUB MEMBERSHIPS

*Club Membership entitles the primary designee and his or her immediate family to use the Club facilities in accordance with the membership category selected. The immediate family of a member includes the spouse of the member and the unmarried children under the age of twenty-five, living at home or attending school on a full time basis. The following are the current classifications of Club Membership. Please be advised that the membership dues may be raised periodically at the Board of Directors' and/or Management's discretion.*

## RESIDENT MEMBERSHIPS

### **Resident Full (\$175/month)**

Resident Full Members are entitled to the use of all the golf, swimming and dining/social facilities of the Club. Full Members do not pay green fees.

### **Resident Social (\$142/month)**

Resident Social Members are entitled to the use of all the, swimming and dining/social facilities of the Club. Social Members receive discounted green fees.

### **Widow Member (\$87/month)**

Widow members are entitled to the use of all the golf, swimming and dining/social facilities of the Club. Widow Members do not pay green fees.

## **Junior (\$120/month)**

The Junior Golf Membership entitles the designated user and his or her immediate family to use the Club Facilities in the same manner as a Resident Full Member and is entitled to use all of the golf, swimming, and dining/social facilities of the Club. An upgrade of the membership is required upon the 30th birthday of the primary member. Both primary and spouse must be under the age of 30 when applying for membership.

*There is a \$30 minimum added to each Resident Membership. If, during any month, a member does not spend at least \$30 at the Club, they will be charged the minimum. If \$30 or more is spent during the month, the minimum charge will be waived.*

## **INTERMEDIATE OUT OF TOWN MEMBERSHIP**

### **Intermediate Out-of-Town**

**54 years of age and younger-Golf Only \$95/month**

**54 years of age and younger-Full Access \$125/month**

**55 years of age and older-Golf Only \$80/month**

**55 years of age and older-Full Access \$105.00/month**

Intermediate Out-of-town applies to anyone who **primarily** resides between 16 – 44 mile radius from the Club. A food and beverage minimum is not required for this type of membership.

## **NON-RESIDENT MEMBERSHIP**

### **Non-Resident (\$43/month)**

Non-Resident Membership applies to anyone who **primarily** resides outside a 45 mile radius from the Club. Non-Resident Members are entitled to the use of all the golf, swimming and dining/social facilities of the Club. Non-Resident Members receive discounted green fees.

## **CORPORATE MEMBERSHIP**

### **Corporate**

**(1<sup>st</sup> member - \$175; up to 2 members - \$165/each; 3 or more members \$144/each)**

Corporate Membership applies to local businesses who want to add a club membership as a benefit for their employees. A corporate member is entitled to have access to all club facilities. The business is responsible for all charges made by the designated member.

*There is a \$30 minimum added to each Corporate Member. If, during any month, a member does not spend at least \$30 at the Club, they will be charged the minimum. If \$30 or more is spent during the month, the minimum charge will be waived.*
